MEMORANDUM OF UNDERSTANDING (MOU)

Between

VASANTDADA PATIL COLLEGE PATODA

And

KISAN KRUSHI PRAKRIYA SAHAKARI SANSTHA JAMB

This is an agreement between Vasantdada Patil College Patoda, Ta. Patoda, Dist. Beed, herein after called "VPCP" and Kisan Krushi Prakriya Sahakari Sanstha Jamb, Tq. Shirur Ka Dist. Beed herein after called "Industry Partner".

1. PURPOSE AND SCOPE

The purpose of this MOU is to clearly identify the roles and responsibilities of each party as they relate to the implementation of the B. Voc. Programme in Soil and water conservation and management at VPCP The Kisan Krushi Prakriya Sahakari Sanstha is intended to help provide service –learning and other opportunities to VPCP students through partnership. To support this goal, VPCP and Industry Partner will work together to conduct service that meets needs of our communities.

Both VPCP and Industry Partner should ensure that program activities are conducted in compliance with all applicable UGC laws, rules and regulations.

In particular, this MOU is intended to establish clear guidelines regarding the service work that will be conducted at VPCP and if required at the site of the Industry Partner.

2. BACKGROUND

This Industry Partner will provide service learning and other opportunity for the course, coordinated between Vasantdada Patil College and Kisan Krushi Prakriya Sahakari Sanstha Jamb.

3. VASANTDADA PATIL COLLEGE RESPONSIBILITIES UNDER THIS MOU

Vasantdada Patil College shall undertake the following responsibilities:

- To enrol the students.
- To verify hours completed by each VPCP participant.
- To provide all the infrastructure facilities to the students.
- To prepare detailed curriculum of the course in consultation with all the industry partners, Board of Studies and industry associations.
- To appoint the faculty and related staff.
- To function all other activities as per UGC rules and guidelines for the course.
- To give the credits and to evaluate the participants.
- To award the certificate/ diploma/degree certificate to the participants.

KISAN KRUSHI PRAKRIYA SAHAKARI SANSTHA RESPONSIBILITIES UNDER THIS

Industry Partner shall undertake the following activities:

- Provide any necessary training required.
- Provide technical knowledge for the software/ equipment required to complete each part of the course and related project.
- Be in attendance for any events coordinated through the partnership.
- Provide guidance and supervision to participants.
- To assists for an evaluation of each VPCP participant.
- To help the participants for the placement.

FUNDING

This MOU does not include the exchange of funds between the two parties. As per UGC Rules the remuneration will be paid to the faculty staff of the Industry Partner for teaching / practicals / project work.

RECORD RETENTION

All records must be retained with VPCP from the date of MOU.

EFFECTIVE DATE AND SIGNATURE

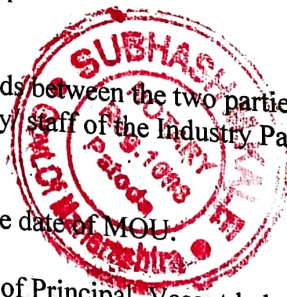
